- a. Jessica reported her time is spent getting ready for NW Glassquest. Alannah reported on their Winter Festival which was successful. They are also responding to some flooding. www.northwestglassquest.com Commissioner Melanie reported the County has created a form for citizens to fill out online, if they have encountered damage. She encourages everyone to be prepared for more king tides this month.
- **b.** Magi reported they have been working on strategic social posting and engagements. Their new website is up and running. They are doing some new digital campaigns and target email blasts that come from out of state.
- **c.** Coupeville Chamber of Commerce is doing strategic planning and analyzing events for 2023. February will bring the Chocolate Walk and she is actively working on the planning.

- d. Langley shared the successful awarding of the Island County combined chamber grant to assist with a guide integrated with the new Transformational Travel planning and Regenerative Places. Langley Cultural Outdoor Museum is in the works on the Cascade Bluff. They are working on the 525 kiosk refurbishment. Mayor Scott created a lodging tax advisory commission.
- **e.** Clinton Chamber is working on membership and a new board development, which is strategic planning.
